She mentioned that these are exciting times in the District and she is looking forward to working with Dr. Stern, faculty, staff, and administration throughout the district this year. Trustee Jay reported about the opportunity to attend several professional development activities at both colleges. She was pleased to see the level of enthusiasm of all the participants. Trustee Jay also attended Dr. Elliot Stern's welcome

reception at Saddleback College. The event was standing-room-only and staff and faculty were excited to meet Dr. Stern. Finally, Trustee Jay attended numerous events on each campus since the last board meeting and was impressed by the richness of each event which included, but were not limited to, the Saddleback College Emeritus Choral event at the Laguna Hills Community Center, the IVC President's Breakfast, which focused on campus safety and free speech, the Part-Time Faculty Social Dinner, the Faculty Association Meeting, and the Support for Mental Health for Students event on January 10.



Trustee Jemal welcomed everyone back from the holiday break and officially welcomed Dr. Elliot Stern to Saddleback College. Trustee Jemal announced that he attended Dr. Stern's welcome at Saddleback College and expressed that Dr. Stern's leadership and creativity is pleasantly welcomed and needed in the District. Trustee Jemal attended the faculty dinner during professional development week with his colleagues and the Chancellor. He echoed Trustee Whitt's comments about how vital part-time faculty are to what we do for students. This important fact was a highlight of the faculty dinner. Trustee Jemal also attended the Irvine

Chamber of Commerce Business Outlook event and thanked IVC for the invitation. Finally Trustee Jemal ended his comments with a quote from Dr. Martin Luther King Jr., in honor of the recently celebrated MLK Day. "All we say to America is, 'Be true to what you said on paper.' Finally, Trustee Milchiker emphasized the

**President Prendergast** reported on several events that he attended including, but not limited to the Swearing-in Ceremony for Tustin's new Chief of Police, Stu Greenberg on January 9 and Dr. Elliot Stern's Welcome Reception at Saddleback College on January 14. President Prendergast wished Dr. Stern much luck in his new position as President of Saddleback College and welcomed him again to SOCCCD. Finally, President Prendergast expressed his excitement for IVC's Astounding Inventions event this upcoming weekend on January 26.



**Trustee Whitt** wished everyone a happy new year and mentioned that her goal in 2019 is to live each day to the fullest and live in the present. Trustee Whitt also reported that she attended several professional development courses at Saddleback College. She enjoyed the cooperative learning and was reminded that faculty can make a difference. Trustee Whitt extended a special thanks to part-time faculty and mentioned that they are the pillars of both colleges in SOCCCD. Finally she thanked the VPs of Instruction and their staff for organizing all of the professional development events.



**Trustee Wright** mentioned that he had minor surgery, and therefore was unable to attend many events on campus, but was with everyone in spirit. He did, however, attend the basketball game between IVC and Saddleback College. In the match, IVC was the winner 51-47. Trustee Whitt thanked Vice Chancellor Gabel for the report on Governor Newsom's budget proposal and its impact on SOCCCD. He was pleased to learn about the 2<sup>nd</sup> year of free tuition under the college promise programs, the increase in Cal Grants, the buy down of STRS and PERS, and the funding for the SC Gateway building. Finally he thanks the

Chancellor and College Presidents for their board reports, as they were nicely done and well written.

- Student Trustee Hoang announced that she was selected to serve on the IVC Homecoming Court and will participate in a number of events associated with Homecoming. Student Trustee Hoang reported that she met with the college student life director and President T.J. Prendergast as part of her outreach to leaders throughout the District. Student Trustee Hoang also reported that her new initiative this semester will be to form a committee of interest groups and underserved populations—comprised of members from the PRIDE committee, undocumented students, student leaders, etc., to learn about the concerns and ideas from these specifics groups on campus. With this committee she will focus on development, particularly around the issues of students' rights and political activism.
- Chancellor's Report: Chancellor Kathleen Burke reported that she attended many of the opening week events and thanked faculty, staff, and administration for all of the excellent events. Chancellor Burke also welcomed Dr. Elliot Stern and expressed her enthusiasm to work with him. Finally, Chancellor Burke reported that she will be in Sacramento at the CCLC conference later this week with Trustees Jay, Jemal, and Milchiker. The CCLC conference will also include a day of advocacy where she will join Trustees in visiting legislators to advocate for SOCCCD. - Irvine Valley College President's Report: President Glenn Roquemore extended a warm welcome to Dr. Stern as the new President of Saddleback College and looks forward to working with him. President Roquemore announced that a traveling exhibit from the Museum of Tolerance will be on campus soon. An opening reception will be held on March 11 beginning at 6pm. President Roquemore also reported that a Campus Safety Summit will be held in Las Vegas and IVC's Chief of Police will serve on the panel with leaders from around the nation. President Roquemore congratulated Chief Meyer on his contributions to the study of campus safety and for the recognition he has received across the country. - Saddleback College President's Report: President Elliot Stern took his reporting time to acknowledge
  the amazing group of employees who welcomed him during his first week at Saddleback College. He
  stated that the warmth and connection that staff and faculty have towards students was a clear
  depiction of why Saddleback College has been so successful for many years. Dr. Stern also thanked Jim
  Buysse for his leadership as Interim President, and his continued help in transitioning the VP of Admin
